Dear Chairmen Brown, McHenry, Reed, Rogers, Cardin, and McCaul and Ranking Members Scott, Waters, Wicker, Smith, Risch and Meeks:

We are writing to thank you for your work on the bipartisan Fentanyl Eradication and Narcotics Deterrence (FEND) Off Fentanyl Act (S. 1271). We look forward to this vital legislation being included in the Fiscal Year 2024 National Defense Authorization Act (NDAA) currently being negotiated.

We represent a broad coalition of stakeholders – families who have suffered the tragedy of losing a son or daughter from fentanyl poisoning, law enforcement officers who are combatting the deadly scourge of this fentanyl epidemic on America's streets, and national security experts who recognize that more must be done to target the transnational criminal organizations driving the illicit fentanyl trade.

We are united in this important fight because more must be done to protect and safeguard the lives of America's children and families. **The FEND Off Fentanyl Act is an important step that Congress must take now**. We applauded its inclusion in the Senate-passed NDAA and urge you to come together once again in a bipartisan manner to ensure it becomes law. This important bill will impose sanctions on the transnational criminal organizations trafficking illicit fentanyl and its precursors as well as on the money laundering that facilitates it. It would also enhance anti-money laundering efforts and strengthen forfeiture authorities related to the drug trade.

The fentanyl epidemic is growing deadlier by the day. Out of almost 107,000 U.S. drug overdose deaths in 2021, nearly two-thirds involved synthetic opioids other than methadone (primarily fentanyl). This category of opioid, primarily made up of fentanyl and fentanyl analogs, was found to be, "the main driver of drug overdose deaths with a nearly 7.5-fold increase from 2015 to 2021," by the National Institute on Drug Abuse. The U.S. drug overdose death toll for 2022 is nearly 110,000, mostly from synthetic drugs like fentanyl, making it the leading cause of death for Americans ages 18-49.

As fentanyl deaths rise, China remains the primary source for its ingredients – known as chemical precursors – that Mexican criminal groups use to make the fentanyl that is killing Americans. Steps taken thus far have not decreased the flow of these illicit opioids into the United States. What's more, Chinese money launderers have become a central element of the financial scheme facilitating the fentanyl epidemic. While the Biden administration recently announced an agreement with China to crack down on the fentanyl trade, the FEND Off Fentanyl Act ensures that those aiding the cartels will face the full force of U.S. sanctions. This legislation is a step forward in our shared fight to combat this epidemic. With inclusion of the FEND Off Fentanyl Act, we can more effectively target those groups and individuals responsible for spreading this poison. This could save the lives of thousands of young Americans.

We thank you again for your leadership and urge you to ensure the FEND Off Fentanyl Act is included in the final FY24 NDAA. America's children and families are counting on your support.
