The bill imposes strict penalties for violating this law, particularly if the defendant knew, or had reasonable cause to believe that a firearm would be used to commit a crime of violence. The bill also criminalizes smuggling firearms out of the United States to complement existing laws criminalizing the smuggling of firearms into the United States.</p> <p>Additionally, the bill strengthens existing laws regarding the transfer of guns to prohibited persons, and ensures that the law prohibits the sale of guns and ammunition to people who intend to transfer them to criminals.</p> <p><u>NAPO supports increased penalties, at both the Federal and state level, for offenses committed with firearms, and joins other law enforcement agencies from across the United States in support of this legislation.</u></p>
